Public Hours at the Consular Section of the American Embassy, Baku

American Citizens Services:

We open Monday to Friday 14:00 p.m. – 17:00 p.m. or by appointment, except for American and Azerbaijani holidays.

Non-Immigrant Visas:

We accept visa applications by initial appointment on

Monday 9.00 a.m. – 12 a.m.
Wednesday 9.00 a.m – 12 a.m.

Visa interviews are generally appointed for the following day after submitting your visa application. You may collect your passport later the same day if not advised otherwise.

Registration

All U.S. citizens residing in Azerbaijan for more than a few days are encouraged to register with the Embassy. Registration allows us to:

- help you more quickly if your passport is lost
- contact you in case of an emergency
- provide information about your whereabouts to family and friends (if you sign a Privacy Act Waiver)
- include you in our warden system, which we use to keep Americans advised of what to do in case of an emergency (you will be included only if you give your permission)

To register, you will simply need to present your U.S. passport at the Consular Section during American Citizens Services' public hours and complete a simple form. A sample form is attached to this pamphlet. There is no charge for this service.

Warden System

Any American citizen who registers becomes part of our warden system. Your name will be given to a volunteer American-citizen "warden" in your area. Your warden would contact you in the event of an emergency to pass on to you information from the Embassy. Your warden may also be able to serve as a point of contact for other useful information from the Embassy.

U. S. Taxes

U.S. citizens and resident aliens generally must file income tax returns, whether they live in the U.S. or abroad. We have federal IRS forms and instruction booklets. Drop by the Consular Section during public hours for forms. There is no fee. Unfortunately, we cannot offer any tax advice.

The nearest IRS office, and the one with jurisdiction over Azerbaijan, is in Berlin.

Passport Services



Americans should safeguard passports as they would any other valuable. If your passport is lost or stolen in Azerbaijan, come to the Consular Section during business hours to apply for a replacement. If you need to renew your passport, you may also come to the Consular Section between 14:00 p.m. – 17:00 p.m., every day except weekends and holidays, to apply for a new passport. In order to issue an American passport, we must have proof of identity and citizenship. If you are renewing a valid or recently expired passport, your passport will serve as proof of both identity and citizenship. Otherwise to prove your identity, you need to provide two forms of photo ID, such as a driver's license. To prove citizenship, you need to provide a certified copy of your birth certificate, certificate of naturalization or other similar documents. All passport applicants must provide two identical 5" x 5" photos in either color or black and white.

Due to new security measures, all passports are now issued in the United States and sent to Embassies. This process takes about two weeks from the day of application. Please plan accordingly. Passport fees changed on 19 August 2002. The fee for an adult renewal is \$97. For a child's passport the fee is \$82. To replace a lost or stolen adult passport the fee is \$127.

Birth Registration

Citizenship transmission requirements vary according to the date of birth. At present a child born to two American citizen parents abroad automatically acquires U.S. citizenship at birth if one of the parents has resided in the U.S. or its outlying possessions before the birth of the child. A child born to one American citizen parent may acquire U.S. citizenship, if the American parent meets the transmission requirement of having resided in the U.S. for at least 5 years, two of which were after attaining the age of 14, prior to the birth of the child.

To register the birth of your child, you should come to the Consular Section during American Citizens Services public hours and bring with you:

- the Azerbaijani birth certificate
- the parents' marriage certificate (if applicable)
- divorce decree of either parent (if applicable)
- the parents' passports
- if only one parent is an American citizen: that parent's proof of 5 years presence in the U.S. (tax returns, etc.)
- the child

After presenting all the necessary documents, you will receive a Report of Birth Abroad, which will serve as the child's proof of U.S. citizenship. The cost is \$65.

Adoption in Azerbaijan

According to the Adoption law of Azerbaijan, foreign adoptions are legally allowed. In practice, however, the Azerbaijani government closely scrutinizes any adoptions of Azerbaijani orphans by foreigners.

Most international adoption cases have been handled by international adoption agencies that have representatives in Baku.

While the consular section of the Embassy processes the I-604 (Request for and Report on Overseas Orphan Investigation), the immigrant visa will be processed in Moscow.

Additionally, the Child Citizenship Act of 2000 allows for the automatic acquisition of U.S. citizenship for both biological and adopted children of U.S. citizens who are born abroad and who do not acquire U.S. citizenship at birth.

The following are the Act's requirements:

1. At least one parent of the child is a U.S. citizen, either by birth or naturalization.
2. The child is under the age of 18.


3. The child must be residing in the United States in the legal and physical custody of the U.S. citizen parent after having been lawfully admitted into this country as an immigrant for lawful permanent residence.
4. If the child has been adopted, the adoption must be final.

Two important notes: the child does not become a US citizen until he or she enters the US, and the child must enter the US with an immigrant visa in order to acquire citizenship under this act.

Informational Services

The American Citizens Services section maintains information for travelers, including brochures and pamphlets on travel safety; travel in the former Soviet republics, and taking pets back to the U.S., among others. We have Consular Information Sheets, which include basic health, safety and travel information, on all countries, including Azerbaijan. We also maintain lists of local lawyers and medical facilities. There is no fee for any of this information.

Federal Benefits & Social Security



Under current agreements, if you are entitled to U.S. federal benefits, such as Social Security or Veterans benefits, you may receive these benefits in Azerbaijan by picking up your checks personally. We can also assist you in contacting the Social Security Administration, the Department of Veterans Affairs and other offices.

Absentee Voting

We have information on how to register to vote and how to obtain absentee ballots for federal and state elections. We can place properly packaged, addressed and stamped (with U.S. domestic postage) absentee ballots in the U.S. Government mail system. We do not, however, sell stamps, weigh items or provide receipts. We cannot place any other items in the

government mail system. More information on voting overseas is available on the internet at www.fvap.gov.

Family Emergencies

If your family needs to contact you because of an emergency at home, or because they are worried about you, they may call the State Department's Citizens Emergency Center at (202) 647-5225. The State Department will relay any message to us and we will attempt to contact you. If you are registered, and if you have signed a Privacy Act waiver, we will be able to provide information about you to your family.

Deaths of American Citizens

If, unfortunately, an American citizen dies in Azerbaijan, the death should be reported immediately to the Consular Section. If the next-of-kin was not with the citizen at the time of death, we will notify them of the death and work with them to carry out their wishes with regard to burial or repatriation of the body. The Consular Section can also, with the next-of-kin's permission, act as a liaison between the family and local authorities. We will also prepare the necessary documents to allow the family to return the body to the U.S., if that is their wish, and a Report of Death of an American Citizen Abroad, which is based on the Azerbaijani death certificate and which can be used in the U.S. for most legal purposes. Be advised that the burial costs cannot be borne by the U.S. government and are the responsibility of the next-of-kin.

Arrests

If you or any American citizen is arrested in Azerbaijan, ask the authorities to notify a Consular Officer at the American Embassy immediately. We cannot get you, or anyone, out of jail. While in Azerbaijan, you are subject to Azerbaijani law and procedure, which are often quite different from U.S. law and procedure. However, if Azerbaijani authorities discriminate against you because you are American, or treat you unfairly compared with normal Azerbaijani procedures, we may be able to intervene on your behalf. Please bear in mind that, while our intervention may help, it may take time.

We can also provide a list of local attorneys, visit you in jail and, if you wish, contact members of your family on your behalf. We can also transfer money, food and clothing to prison authorities from your relatives for your benefit. We encourage everyone to work via local lawyers. In the end, only Azerbaijani authorities have the power to resolve a dispute.

Disasters & Civil Disorder

If there is a natural disaster or some civil disorder, we will use our warden system to notify American citizens and provided appropriate instructions and advice. If you are caught in a disaster or disturbance, let your relatives know as quickly as possible that you are safe. You may contact

the Consular Section and ask us to pass a message to your family. Above all, remain calm, follow events through news reports and try to follow instructions from the Embassy. In the event of a disaster, we give priority to Americans who have been hurt or who are in danger. Also, we may be facing the same problems that you are, such as a lack of fuel, telephone connections or electricity. Please be patient with us if you are safe and sound.

Notarial Services



American citizens and others may receive a variety of notarial services at the Consular Section.

Documents, such as affidavits and powers of attorney, for use in the U.S. may be notarized. There is a \$30 fee for the first document, and \$20 for each additional copy.

Also, legal documents issued in Azerbaijan, such as birth certificates, can be authenticated for use in the U.S. To have such documents authenticated, they must first be "legalized" by the Azerbaijani Ministry of Justice and the Ministry of Foreign Affairs. After they have been authenticated at the Foreign Ministry, we can authenticate the signature and seal of the Ministry's representative. There is a \$30 fee for this service.

In some cases, affidavits executed at the Consular Section may be used for legal purposes in Azerbaijan after the signature and the seal of the Consular officer has been authenticated by the Ministry of Foreign Affairs. We cannot, by law, authenticate documents issued in the United States. Such a document must be authenticated first at the U.S. local then the state level. Then, it must be authenticated by the Authentication Officer at the U.S. Department of State in Washington, DC. Finally, it must be authenticated by the consular section of the Azerbaijani Embassy in Washington, which charges a fee for this service. What We Can't Do...

- help Americans extend or obtain valid Azerbaijani visas
- provide American Citizens Services to U.S. Resident Aliens ("Green Card" holders)
- get Azerbaijani laws waived because you are an American
- give money or a financial guarantee, or cash a check
- authenticate signatures and seals from the U.S.
- provide legal advice or representation
- become involved in private legal disputes
- provide postal services, forwarding or storage
- provide access to a fax or e-mail
- act as an intermediary for financial transactions
- trace missing persons in the U.S.
- provide medical services
- serve as a travel agency
- serve as an interpreter or translator

Azerbaijani Visas for Americans

A passport and a visa are required to enter Azerbaijan. You can obtain additional information regarding Azerbaijani visas through their website which is <http://www.azembassy.com>. The Azerbaijani Embassy is located in Washington and their number is (202) 337-3500. You will also have to show your visa in order to depart Azerbaijan. Americans can purchase one-entry visas at the airport at a cost of \$40.

Azerbaijani Customs

Travelers to Azerbaijan must fill out a customs declaration upon arrival that is to be presented to customs officials when departing the country. You should declare all items of value on this form. Failure to declare currency and items of value can result in fines or other penalties. If your customs form is lost or stolen report the loss to the police to obtain a certificate to show customs officials when you depart the country.

Azerbaijan's customs officials may enforce strict regulations concerning the temporary importation into or export from Azerbaijan items such as alcohol, tobacco, jewelry, religious materials, art or artifacts, antiquities and business equipment. Personal medicines with a doctor's statement can be imported without the permission of the Azerbaijani Department of Healthcare. US citizens may not import firearms into Azerbaijan. While there is no limit to the amount of currency imported, if more money is exported than imported, the traveler is obligated to prove it was legally obtained.

The Ministry of Culture must license any valuables such as artwork, antiques, jewelry, carpets, paintings, etc. purchased in Azerbaijan. This license describes the object, assesses its value and provides permission to export it from Azerbaijan.

Azerbaijan allows the export of up to 600 grams of caviar. However, under US law, the maximum amount that can be legally imported is 280 grams.

More specific information on quantities of items which can be imported duty-free can be provided by the U.S. Embassy in Baku, Azerbaijan.

Crime and Credit Cards

Inflation, unemployment and the breakdown of the social fabric have contributed to an increase in violent crime. Americans, and other foreigners, are seen as particularly choice targets. You should take all due precautions to safeguard your belongings, especially in hotel rooms, on trains and in public places. If you are the victim of a crime, report it immediately to the local police and to the Consular Section.

Azerbaijan is largely a cash economy. Traveler's checks and credit cards are accepted at only a few locations. You should be extremely careful in protecting your cash. If you are traveling with your family, you may want to distribute your money among the members of your family and have each person use several hiding places. When you are able to use your credit card, you should exercise caution to make sure the clerk or attendant does not keep a copy of the impression made from your credit card or write down the card number. You should request that any carbons made of the credit card impression be given to you. You should also verify all charges made to your card to prevent unauthorized use of your credit card number. If your credit card is stolen, you should call the appropriate number in the U.S. below to cancel it immediately:

Traffic safety is also something all travelers should keep in mind. Roads in Azerbaijan may be in very poor condition and unlit. Traffic signals, when actually working, and rules of the road are often completely ignored. Motorists race about recklessly and at excessive speeds. Pedestrians enjoy no right of way and are advised to be cautious when crossing streets.

Medical Emergencies and Health Concerns

All Americans traveling to Azerbaijan should make sure that their immunizations are up-to-date. Azerbaijan's water systems are often aging and poorly maintained. Water should be filtered and purified. A good rolling boil for 10 minutes will kill most bacteria and a good filter will remove most heavy metals and impurities. Several brands of bottled water may be purchased locally. Meats should be cooked thoroughly and fruits and vegetables should be washed and peeled.

If you have a medical emergency while in Baku, you may wish to contact the Consular Section for a list of English speaking physicians and/or facilities available.

Medical Evacuations

The Consular Section has limited information on various air ambulance companies that perform medical evacuations to Germany, Finland or the U.S. While we can help you or your family make contact with a medevac service, **the U.S. Government cannot pay for your medical evacuation. You may wish to make sure that you have medical evacuation insurance, available from many private companies, before the need arises.**

Telephone Service

You can place international calls from most hotels and guesthouses. If you have a direct dial international phone line, you may call the U.S. by dialing -00- and then the area code and phone number you need. To speak with an international operator, dial -107-. While the answer is initially in Azerbaijani, most operators speak English or will connect you to someone who does.

Marriage in Azerbaijan

If you are coming to Azerbaijan to get married or plan on getting married while in Azerbaijan, pre-planning is a necessity. This process can be lengthy and frustrating if the proper steps are not taken. The way to avoid this is to contact the Consular Section for detailed instructions. We are available for any questions regarding marriage to a Azerbaijani citizen during regular American Citizen hours or by appointment. The laws of the Republic of Azerbaijan require that either the bride or the groom be a citizen of Azerbaijan in order to marry legally in the country.

Non-Immigrant Visas

Click here for complete information on non-immigrant visa procedures at the US Embassy in Baku. All applicants must pay a non-refundable \$100 MRV processing fee. Applicants must have a completed DS-156 application form, one passport size photograph and a valid international passport.

214(b)

Section 214(b) of the Immigration and National Act states that all applicants must prove strong family, social, economic and financial ties to their residence abroad and that the purpose of travel is authorized under the visa category. If an applicant cannot prove that they do not intend to immigrate to the U.S. or that the purpose of travel is authorized, the law says that they cannot receive a visa.

All applicants must comply with this section of the law based on their own situation in Azerbaijan; your sponsorship and your financial status in the U.S. **are not sufficient** for an applicant to obtain a visa.

Immigrant Visas

We do not process or issue immigrant and fiancée visas in Baku. They are processed and issued at the American Embassy in Moscow, Russia. The Embassy in Moscow may be contacted at: 00-7095-728-5577. The address is:
